## Instrument of Authorisation 2021

### Kelso State School

#### Requirement to tell student about a suspension and exclusion under Chapter 12, Part 3, Division 1, of the *Education General Provisions Act 2006 (EGPA)*

I, Darrell Sard, Principal of Kelso State School **authorise** the persons who are from time to time holders of the positions of Deputy Principal at this school, to tell a student and/or parent on my behalf of my decision to suspend and/or exclude the student under section 293 of the EGPA.

I further authorise the persons who are the holders of the positions of Deputy Principal to inform the student and/or parent of decision to exclude that student under section 295(2)(a) of the EGPA. This authorisation includes telling the student and/or parent that their suspension under section 293 has ended and the student may resume attendance at the school.

A Deputy Principal who informs a student acts in my name.

The effect of this authorisation is as follows:

- A suspension of a student under section 293 of the EGPA will start when the Deputy Principal tells the student and/or parent about the decision, as per section 293(3) of the EGPA.
- When a Deputy Principal tells a student and/or parent of my decision not to exclude the student, that the student's suspension has ended and that the student may resume attendance at the school, the student and/or parent is then considered to have been advised in satisfaction of section 295(2)(a) of the EGPA.
